### City Permits

### County Permits

<p>New York State Law requires people to register their business in the county in which the business is located. You must go to the Westchester County Clerk's office to register. If this is a Partnership Certificate, <i>all partners need to be present</i> in order to sign in front of the Notary Public.</p> <ul style="list-style-type: none"> <li>• You must come into the County Clerk's Office with proper identification such as a driver's license or Passport and a \$33.00 processing fee.
